2. What information does Alawar Premium Limited collect and process?

Use of the Service

Alawar Premium Limited Services do not collect Personal information from your Device (as this term is defined below) when you browse our websites and request pages from our servers. This means that, unless you voluntarily and knowingly provide Alawar Premium Limited with Personal information, we will not know your name, your e-mail address, or any other Personal information.
